Motion to approve the agenda for August 19, 2009 by Councilperson Beel; seconded by Councilperson Reid. Upon voice vote, the motion carried.

PUBLIC HEARINGS:

- **2009 Property Tax rates for Residential, Commercial and Personal Property – Public hearing opened at 6:12 p.m.** Brent Bury gave details about the tax rates and explained how the rates are computed.

Public Comment – C. Greg Correll, 7823 Brand Ave. – in 2006 the assessed values went up; in 2007 the assessed value went up 500%; 2008 the assessed values went down 25%. Need to use restraint on taxing residents.

Wade Fish, 7706 Circle Dr. – wanted to know what last year's rate was and was answered by Brent. **Hearing closed at 6:55 p.m.**

Bill No. 09-04 was passed by the Council and will become Ordinance No. 607 (number corrected) if signed by the Mayor or as otherwise provided by law.


