RESOLUTION 19-02

A RESOLUTION OF THE CITY OF NORMANDY, MISSOURI SUPPORTING THE CITY OF NORMANDY'S APPLICATION FOR PARKS GRANT ROUND-20 AND AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH THE ST. LOUIS COUNTY MUNICIPAL LEAGUE PARKS COMMISSION.

WHEREAS, the City of Normandy, Missouri has identified the need to demolish the antiquated and vacant structure known as 7302 Pasadena Blvd, "The Normandy Firehouse";

WHEREAS, the City of Normandy, Missouri would like to provide improvements to this area, once demolished, by establishing a Memorial Monument dedicated to "Fallen First-Responders" (*Police, Fire and EMS Services*) with amenities such as a water park/splash fountain, picnic tables/benches and electricity;

WHEREAS, the St. Louis County Municipal League Parks Grant Commission is releasing a 2019 park grant construction applications (*Grant Round-20*) which may entitle the City of Normandy to as much as \$375,000.00 in available grant funds;

WHEREAS, the City of Normandy, Missouri plans to make application for this St. Louis County Municipal League's Parks Construction Grant which is due on Friday, August 23th, 2019;

WHEREAS, the City of Normandy, Missouri plans to partner in this construction grant application with the Municipality of Pasadena Hills and with the Northeast Fire Protection District;

WHEREAS, this St. Louis County Municipal Parks Commission Grant is a reimbursement type grant that will reimburse the City of Normandy for project expenditures upon project completion and final inspection of project by the Parks Commission;

NOW, THEREFORE, BE IT RESOLVED, that the City of Normandy, Missouri hereby authorizes the MAYOR to execute a partnership application with the Municipality of Pasadena Hills and with the Northeast Fire Protection District for Round-20 of the St. Louis County Municipal League *Parks Commission Grant* which is due Friday, August 23th, 2019 before 4:00 pm.

Section One.

An application be made to the Municipal Parks Grant Program in the County of St. Louis for a grant-in-aid for some or all the cost of the project, reimbursable by the Commission upon completion by the City.

Section Two.

That a project proposal be prepared and submitted to the Municipal Park Grant Commission.

Section Three.

The governing body authorizes the Mayor to sign and execute the necessary documents for forwarding the project proposal application to the Municipal Park Grant Commission.

Section Four.

If a grant is awarded, the City of Normandy, Missouri will enter into an agreement or contract with the Commission regarding said grant.

This Resolution shall be in full force and effect after its passage and approval according to law.
