

## RESOLUTION 16-01

**A RESOLUTION OF THE CITY OF NORMANDY, MISSOURI AUTHORIZING THE CITY OFFICE MANAGER TO ACCEPT THE LOW BID OF \$90,179.69, SUBMITTED BY “B&P CONSTRUCTION, INC.” TO PROVIDE REMOVAL AND REPLACEMENT OF SPECIFIED DEFECTIVE CONCRETE SIDEWALK SLABS AND DRIVEWAY APRONS IN WARD ONE; FINANCED WITH C.D.B.G. FUNDS AND WITH CITY OF NORMANDY FUNDS.**

WHEREAS, invitations to bids were delivered to concrete contractors on Monday, November 16<sup>th</sup> 2015;

WHEREAS, bid packages were available for collection by contractors at the front counter of City Hall on Monday, November 16<sup>th</sup> 2015 at 12:00 noon;

WHEREAS, bids were officially opened at 1:00 p.m., Wednesday, December 2<sup>nd</sup>, 2015 at City Hall and publicly read out loud;

WHEREAS, a bid of **\$90,179.69** was submitted by **B&P Construction, Inc.**; a bid of \$92,500.00 was submitted by Shamrock Concrete, Inc.; and No bid response was received from Ready To Roll Concrete;

WHEREAS, the City of Normandy has allocated C.D.B.G. Funds totaling **\$66,000.00** (*Fund Account 4530 at \$33,000.00 and Fund Account 4540 at \$33,000.00*) to be utilized for this street improvement project totaling **\$90,179.69**;

WHEREAS, the City of Normandy has will be required to allocate \$25,000.00 (\$24,179.69) from “General Revenue Fund” (*Roads & Bridges Tax / Restricted Street Trust Fund*) to cover the difference between the \$66,000.00 of C.D.B.G. Funds and the \$90,179.69 total project cost;

NOW, THEREFORE, BE IT RESOLVED, that the City of Normandy, Missouri hereby accepts **the low bid of \$90,179.69 from B&P Construction, Inc.** for the replacement of specified concrete sidewalk slabs and driveway aprons throughout Ward One in the City of Normandy.

### Section One.

The City Office Manager is hereby authorized and directed to execute and enter into, on the behalf of the City, an agreement with B&P Construction, Inc. and with St. Louis County Office of Community Development to use **\$66,000.00 of Community Development Block Grant Funds** and **\$25,000.00 of City of Normandy Funds**, for the replacement of specified concrete slab sections throughout Ward One the City of Normandy as outlined per bid specifications.

Section 2.

This resolution shall be in full force and effect after its passage and approval according to law.
