Greetings neighbors, and best wishes for the coming Holiday Season. I would like to take this opportunity to count our many blessings here in the City of Normandy, and to applaud our City staff for the outstanding work they are doing. We are fortunate to have this team of professionals managing the business of our City. We also have a City Council that has rolled up its sleeves and is doing the work necessary to make and keep our community a great place to live. It is a pleasure working with them all. Among the items to look forward to this winter is the delivery of our new Public Works

Department truck with plow and salt spreader, and the installation of a new roof at the Public Works Building. As part of our continued dedication to financial transparency, we are accepting bids and will be selecting a firm to perform the 2022 financial audit. This will be the first time in over 12 years that the City of Normandy has had an independent audit of our finances.

The vision statement for the City of Normandy reads "...a safe and family-friendly community that is the historic heart of North St. Louis County with a business corridor that attracts visitors from the entire region." A lot is happening to assure our vision becomes reality. We now enjoy a renewed and positive relationship with our University of Missouri-Saint Louis neighbors who have committed \$120 million to infrastructure improvements as part of the initial phase of the new North St. Louis County Business District located on thirty-five acres of their south campus.

In addition, our immediate neighbor to the east of City Hall will soon be the U.S. Department of Agriculture, and a \$102 million investment into their new, state-of-the-art food-testing facility. The final planning process is underway, with construction scheduled to begin in the summer of 2023, with over \$220 million of investment coming in 2023, more are likely to follow. The City is currently engaged in conversations with other investors who appreciate what is happening in the City of Normandy and the business opportunities it provides. The vision of a revitalized Natural Bridge Business corridor is moving beyond a dream.

Normandy is on its way to receiving its Tree City USA certification.

The number of old-growth oaks in our City certainly benefits all of us by providing a greener, healthier community, but the work and cost of properly maintaining our urban forest can also present challenges.

The National Arbor Day Foundation and the National Association of State Foresters have established standards for becoming a Tree City, and once adopted, Normandy will benefit from assistance in creating a viable tree-management plan and make available to us additional grant opportunities. One of the required standards is the creation of a City Forestry Advisory Committee, appointed by the Mayor with the approval of the City Council, whose duties will include the development of a short- and long-term plan for the maintenance, removal, replacement, and general care of our trees along streets, in parks, and other public areas. MESSAGE from the City Administrator

The Administration is currently working hard on several projects to improve the transparency, responsiveness, and efficiency of our services. For instance, the Council recently passed our Annual Budget for Fiscal Year 2023. The budgeting process revealed that the City is facing significant inflationary pressure as well as stagnant revenues from a declining population and changes in the state laws regarding the collection of Use Taxes. The City has adjusted and is looking to cut, trim, and save where we can, while also looking to improve services that have struggled in recent years due to the struggles faced at City Hall.

As we move forward into the new budget year, we have begun work preparing for an independent audit of Fiscal Year 2022. This means reviewing and updating internal control procedures and reporting methods to ultimately improve the transparency and accountability of our budget. We are currently scheduled to complete this audit, the first in over 10 years, in March of 2023.

I hope that all residents enjoy their holiday season and have a Merry Christmas. Happy Holidays,

Stay safe and warm this winter.

- 2. After the upfront balance is paid, the remaining balance will be divided evenly over the next 12 months and added to your monthly bill.
- 3, And finally, you'll be enrolled in a Budget Billing plan to keep your future monthly bills consist year-round.

As the season quickly approaches, the officers of the Normandy Police Department recognize that this presents certain seasonal hazards and is an opportune time for crime. We hope these holiday safety tips help keep our citizens safe and stop the Grinch from stealing your holiday spirit!

Travelina?

- Get an automatic timer for your lights.
- Ask a neighbor to watch your home, shovel snow, and park in the driveway from time to time.
- Don't forget to have mail and newspaper delivery stopped.

Shopping?

- Stay alert and be aware of what's going on around you.
- Park in a well-lighted space, and be sure to lock the car, close the

windows, and hide shopping bags and gifts in the trunk. "Out of sight, out of mind!"

• Avoid carrying large amounts of cash; pay with a check or credit card whenever possible.

Porch Pirates?

• Track deliveries online and confirm delivery has occurred.

• Ask family members or neighbors to pick up packages as soon as they are delivered.

• See if the post office or store the product is being shipped from can hold the package for pick up.

Parking?

• Always lock your vehicle and store all items out of sight.

• Help prevent your vehicle from being stolen by always locking your car and using anti-theft devices.

• And although it's cold, never leave your vehicle running while you run inside your home or a store—even if for only a minute or two.

COMMUNITY RESOURCES

Epworth Children and Family Services provide service to at-risk youth, teens, and families with access to basic needs and emergency resources. The services provided include: foster care; mental health; housing; crisis intervention; and home-based counseling. The Epworth Drop-In Center at 314-952-8689 for youth ages 11 to 20 is located at 7520 Natural Bridge Road, open Monday through Thursday, 12 p.m. to 5 p.m., and Friday from 1 p.m. to 5 p.m. Hot meals are prepared daily; case management services help with housing, education, employment, and legal issues; free medical services are also available. Epworth has a recreation room, computer lab, and a full-service kitchen as well as laundry, shower, and clothing and food pantry. Epworth has an Emergency 24/7 Helpline that can be reached at 314-727-6294. Visit www.epworth.org for more details about their programs.



The City has been receiving complaints about stray dogs roaming our streets, which has been a challenge as St. Louis County Animal Control has been overwhelmed and has not been very helpful in picking up these strays. Normandy Police Department has done what it can, but does not have the facilities within the precinct to board stray animals. As they say, the squeaky wheel gets the grease, so please continue to call St. Louis County Animal Control at 314-615-0650, for nuisance dogs. If you believe any dog to be a threat or a danger to the community, please call 911. As a reminder, it is illegal by ordinance to own or keep any Pit Bull or Rottweiler in the City of Normandy, including "Any dog which has the appearance and characteristics of being predominantly of the breeds of bull terrier, Staffordshire bull terrier, American pit bull terrier, American Staffordshire terrier, any breed commonly known as pit bulls,...".

We want to welcome all new residents to Ward 4 since the winter of 2021 and appreciate your interest in living with us, as neighbors, and making Normandy your home. If the residents could report any burnt-out street or park lights to City Hall, our Public Works Department has a supply to perform bulb replacements.

Pet dogs must be on a leash when outside, at all times, near your home, and or when you are walking. When you walk your dog, please bring a bag to clean up after it, so as not to offend other homeowners and residents using any green public space. Please protect the health of your pet cats and always keep them inside your home, since there is an abundance of feral cats in our neighborhoods. Feral cats jeopardize the safety of our wild birds and cause their numbers to decrease at an alarming rate. Birds are important pollinators of flowers and consume insects that reduce the overuse of pesticides. There is no easy answer to this problem, but we may be able to come together and find a creative solution to it.

Waste Management is in its second year of providing sanitation services for the City of Normandy. Beginning January 1, 2023, there will be a \$6.72 billing increase per month but no anticipated scheduling changes. Trash, recycling, yard waste, and bulk pick-up are all collected every Monday. Please note:

- Place trash and recycle carts at the curb by 6:00 a.m., lid opening facing the street, and a minimum of 3 feet apart.
- Bulk pick-up is limited to 2 items per week, not to exceed 100 pounds each.
- Old mattresses must be shrink-wrapped, or they will not be picked up.
- Waste Management will pick up brush that is tied in 3-foot bundles.
- Other yard debris can be placed in brown yard bags, not to exceed 12 bags per week.
