Treasurer report Charles Ellis:

Mayor Pro Tem Maurice Hunt:

- I feel we should charge for additional bulk pick up
- Public works now has changed locks and camera at the garage
- We need to get another trash truck because the truck we have will not handle those big bulk items. It will cause the trucks to break down faster.
- I would like to increase the fees for trash service from 62.50 to \$65.00 a quarter. It has been 7 years sense we raised the fees.
- Regina has videos of residents cursing and yelling at the sanitation workers.
- Regina has cleaned up public works and it looks like an office now.
- We found out all of sanitation workers have been carrying 9mm weapons on their hips
- Regina is doing a check list on the sanitation truck for anyone driving to fill out prior to the route.
- Due to the bills incurred by P Green, Sharon will call the vendors and try to work out deals

- We owe about \$144,000.00 from P Green.
- We have \$103,000.00 in a money market if the council agrees put it on the market and keep the cell tower money separate.
- The concrete bill we must paid.
- Gerstners bill wants 11,000.00 for the lights along Natural Bridge,
- Blue Grass wants \$31,8500.00 for and they agreed \$16,000.00 in 30 days
- Gamma wants \$8000.00
- Tim did not complete anything while he was here. No projects were finished.
- Sharon will send a copy of all the bills to Steve Garrett for review, and he will keep the council advise as to what is happening.
- If we had a PO system in place with Green this would not have happened
- We need to leave the Patrick Green bills to Steve, set them aside.
- Move the money from Simmons to the General Fund to pay off these old bills and get caught up.
 - Motion to approve moving the money approved by Councilperson Evans, Councilperson Smith, and Councilperson Martin.
 - Upon Roll Call Motion passed
- Please contact the mayor for any additional information that is needed from the council.
- We need to set up town hall meetings to get emails for residents
- We need to do a workshop for the council people to help with their wards.

- I would like to see 3 bids from other trash services to compare with ours.

- We need to review all the minutes to find out what was agreed on and should be paid.

- Why did we supply recycling bins to the residents?
- I agree we need two trash trucks; we need other bids.




