

#### REPORT OF COUNCILMEMBERS

### Mayor Hunt:

# Ward 4 Councilperson Kimberly Knox and Bob Reid:

- Councilperson Knox stated she would like to comment on the flowers at the fountain, it is looking better.
- We are still having sidewalk issues
- If you get an email it would be nice if you would just respond to it, so we know it was received.
- I would also like to ask about the city server.
- I would also like to let everyone know about the food pick up from Beyond Housing for 11am to 1 pm every week
- Can we talk about a parade or something for the graduating class of 2020?
- Can we get an update on the audit for the city? When is it going to happen?

#### Chief Mininni

- In response to the speeders on Bermuda, I will have the trailer put up there again to try and help.
- We are starting to see what the Corvid 19 is doing to the residences here in Normandy between neighbors
- Last week a woman with 5 children gave up her kids to St. Louis County because she could not take care of them.

#### Public Works Director Regina Fitzgerald:

- I would like to have you consider the ordinance that we are showing you tonight and I would like for you to consider bulk pick up every three months.
- Recycling will resume on May 15<sup>th</sup>, 2020 I will be following the truck to insure we are getting a clean load.

#### Judge Jennifer Fisher:

- I am glad to meet all of you, I have asked several times about meeting with you all and I have not up to now so, thank you.
- There are several changes in courts that I need to discuss with you. These orders
  come from the presiding Judge in St. Louis County which is my boss. I feel like all
  the decisions that are made in the city dealing with courts should come through me
  because I have to sign a paper saying we are all in compliance with what the
  supreme courts says.
- I understand you are looking for a new judge. (Mayor Hunt stated, "No, we have not renewed your contract and per our ordinance we have put it out."
- I understand you are cross training court personnel with city hall and that is not allowed according to our court rules. I would like to discuss this further with the mayor and the council.

## City Clerk:

- We need to put out the RFQ then the RFP for the Judge position
- We are going to need additional cleaning after we open. Courts will have to clean
  and sanitize after every 10 people and we do not have the cleaning staff for that. We
  will also have to clean counters and doorknobs at the front area to keep everyone
  safe. We are attempting to get 3 bids for the cleaning, and I will submit those to the
  council.
- Councilperson Martin and I went over some of the purchasing orders, but she will discuss it further in the work session.



### Sgt. Sappington 7725 Dartmoor


 There are 26 lights out in the area, and they have been out for months, prior to Rodney's death.
