One is the Village of Glen Echo Parks this is essentially a renewal of a contract for service we have provided for years. There are some adjustments for inflation with that exception it is essentially the same contract. So, if it's the Council's pleasure, I'm looking for a motion to allow Mayor Beckmann to enter an agreement to provide police service for the Village of Glen Echo Park police service contract, if I can have a motion to give Mayor Beckmann the motion to move into this contract.

This is an initial agreement we have never done service for them in the past, and once again Chief Hall, Sgt. Sanders, and our attorney have been involved in negotiating this. The parties here unfortunately do not have a copy that, I sent it by email and had some issues of that getting through, I have a copy of it here if anybody wants to look over it again. But what I will look for is a motion to authorize Mayor Beckmann to enter a contract with police service with the City of Bel-Ridge. I am looking for a first and if there is a second, we will have comments and questions.

Mayor: If there are no comments or questions,

Chief Hall give information on what is going to be proved to the City of Bel-Ridge and what the calculations covered within the contract. The coverage of the vehicle and the occupation of a substation area space at the City of Bel-Ridge building. Stating the estimation that was made covered up to 8 police officers.

Chris Graville stated there is one correction and Bel-Ridge will reimburse the City of Normandy for the maintenance of the vehicles, cost of insurance, which was an important point the Chief wanted, if they were not to maintain their own vehicles, was to cover their own cost of the vehicles which was is now in there. Part of the reason it got out late, the contract starts July 1 and they wanted to make sure that it was a healthy transition period to both hire and dispose of equipment acquiring any necessary new equipment.

Chief Hall explained how the policing was structured to police Bel-Ridge., by adding an addition sector or expand the sector.

Mayor: Are there any other questions? Let's move to a voice vote on the motion made




