

**AN ORDINANCE AMENDING TITLE II, CHAPTER 215,
OF THE CITY OF NORMANDY, MISSOURI, CODE BY
ADDING A NEW SECTION PERTAINING TO THE
EXTERIOR COLLECTION UNITS, DONATION BOXES
AND OTHER SIMILAR DEVICES**

WHEREAS, the placement of exterior collection units, donation boxes or similar devices in and near public rights of way can interfere with the free and safe flow of vehicular and pedestrian traffic; and

WHEREAS, the placement of exterior collection units, donation boxes or similar devices in and near roadways diminish motorists' field of vision, have a tendency to distract motorists and otherwise pose a hazard to public safety; and

WHEREAS, exterior collection units, donation boxes or similar devices are used for the collection of old clothing, shoes and similar other material which is resold for profit instead of donations for the needy; and

WHEREAS, exterior collection units, donation boxes or similar devices have a tendency to pose a hazard to public safety by attracting vermin; and

WHEREAS, a proliferation of exterior collection units, donation boxes and similar devices constitutes an eyesore; and

WHEREAS, it is the desire of City Council of the City of Normandy to preserve our neighborhoods and the safety of our residents;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
THE CITY OF NORMANDY, MISSOURI, AS FOLLOWS:**

Section One. Chapter 215 is hereby amended by the addition of a new Section 215.615 which shall read as follows:

TITLE III

**PUBLIC HEALTH, SAFETY AND
WELFARE**

CHAPTER 215

OFFENSES

SECTION 215.615

EXTERIOR COLLECTION UNITS, DONATION BOXES AND SIMILAR DEVICES

1. It shall be unlawful for any person to park, place or suffer the placement of any exterior collection units, donation boxes or similar devices in or upon any street, highway, roadway, designated fire lane or sidewalk in the City of Normandy.
2. It shall be unlawful for any person to park, place or suffer the placement of any exterior collection units, donation boxes or similar devices upon any lot or property in the City of Normandy.

Section Two.

It is hereby declared to be the intention of the City Council that each and every part, section and subsection of this Ordinance shall be separate and severable from each and every other part, section and subsection hereof and that the City Council intends to adopt each said part, section and subsection separately and independently of any other part, section and subsection. In the event that any part of this Ordinance shall be determined to be or to have been unlawful or unconstitutional, the remaining parts, sections and subsections shall be and remain in full force and effect.

Section Three.

The Chapter, Article, Division and/or Section assignments designated in this Ordinance may be revised and altered in the process of recodifying or servicing the City's Code of Ordinances upon supplementation of such code if, in the discretion of the editor, an alternative designation would be more reasonable. In adjusting such designations the editor may also change other designations and numerical assignment of code sections to accommodate such changes.

Section Four.

This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
