AN ORDINANCE APPOINTING CHIEF MININNI, TO REPRESENT THE CITY OF NORMANDY, MISSOURI, AT THE ACCIDENT REDUCTION CORRIDOR ("ARC") ZONE COMPACT

WHEREAS, The Cities of Berkeley, Cool Valley, Edmundson, Normandy, Northwoods, Pine Lawn, St. Ann and Woodson Terrace, being eight contiguous municipalities along a seven mile corridor of I-70 wish to work together to help reduce the number of impacts, injuries and fatalities along said stretch of I-70; and

WHEREAS, The City Council for the City of Normandy has determined that the number of impacts, injuries and fatalities along said stretch of I-70 is disproportionately high and represents a serious risk to the health, safety and welfare of its citizens; and

WHEREAS, <u>Section 70.220</u>, RSMo, authorizes Cities to work in a cooperative manner; and

WHEREAS, The City Council for the City of Normandy, wish to be a part of the cooperative ARC Zone Compact, which will serve as a cooperative body for the eight contiguous municipalities, which through a collaborative effort will seek to consider and implement coordinated traffic enforcement measures aimed at reducing the incidents of impacts, injuries and fatalities along said stretch of I-70; and

WHEREAS, The City Council for the City of Normandy has determined that the important goal of reducing the number of impacts, injuries and fatalities on said stretch of I-70 will be best served through the cooperation of the eight contiguous municipalities; and

WHEREAS, each of the eight member cities of the ARC Zone Compact is to nominate a City Representative to attend and participate in all meetings of the ARC Zone Compact; and

WHEREAS, the City of Normandy wishes to appoint Chief Mininni as its Representative on the ARC Zone Compact.

BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF NORMANDY, MISSOURI, AS FOLLOWS:

<u>Section 1</u>. Chief Mininni is hereby appointed to serve as the City's representative at the ARC Zone Compact.

<u>Section 2</u>. Chief Mininni, as a member of the ARC Zone Compact shall have the authority of the City to attend all meetings of the ARC Zone Compact, on the City's behalf and to work with the other seven City Representatives in developing and drafting a proposed "Master Traffic Enforcement Plan" for subsequent consideration by the City Council for the City of Normandy.

<u>Section 3</u>. The proposed "Master Traffic Enforcement Plan" drafted by the eight members of the ARC Zone Compact shall include, but is not limited to, consideration of the following matters:

- 1. Promoting public education and awareness of the ARC Zone compact and its purpose to encourage vehicle operators to travel at safer speeds and to reduce the number of impacts, injuries and fatalities along said stretch of I-70;
- 2. Setting targets for the reduction of impacts, injuries and fatalities in the ARC Zone;
- 3. Promoting cooperation with the Municipal Court Judges and Staff, to develop and enforce an appropriate fine schedules for traffic violations occurring in the ARC Zone;
- Promoting cooperation with the Missouri Department of Transportation to ensure the procurement and placement of all required signage for the ARC Zone; and
- 5. Determining the best practices in traffic control and safety enforcement and how those practices might best be employed in a cooperative manner.

<u>Section 4</u>. This Ordinance shall take effect and be in full force immediately following its passage and being signed as provided by law.
