AN ORDINANCE AMENDING ARTICLE II OF CHAPTER 500 OF THE NORMANDY, MISSOURI CITY CODE RELATING TO ADOPTION OF VARIOUS ST. LOUIS COUNTY TECHNICAL CODES.

WHEREAS, the City of Normandy contracts with the County of St. Louis for enforcement of various technical codes; and

WHEREAS, as a condition of said contract, the City must ensure that its applicable ordinances are identical in substance to those of St. Louis County; and

WHEREAS, St. Louis County has amended some of its technical codes, including those for electrical, plumbing and mechanical; and

WHEREAS, the said amendments to the said St. Louis County technical codes have been of file with the City Clerk for ninety (90) days as required;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORMANDY, MISSOURI, AS FOLLOWS:

Section One.

Subsection A of Section 500.050 of Article II of Chapter 500 of Title V of the Normandy, Missouri City Code is hereby amended by repealing in full said Subsection A and in lieu thereof, enacting a new Subsection A to read as follows:

SECTION 500.050 ELECTRICAL CODE

(NOTE: Subsections B & C are not altered, amended, or affected in any way by this amendment and remain in full force and effect. For that reason, these subsections are not set forth here in full.)

A. Adoption: The Electrical code approved by the County of St. Louis on July 14, 2010 as Ordinance #24439 (Exhibit A) and will become effective on November 1, 2010, is hereby adopted as the electrical code of the City of Normandy as if set forth here in full.

Section Two.

Subsection A of Section 500.060 of Article II of Chapter 500 of Title V of the Normandy, Missouri City Code is hereby amended by repealing in full said Subsection A and in lieu thereof, enacting a new Subsection a to read as follows:

SECTION 500.060 PLUMBING CODE

(NOTE: Subsections B, C & D are not altered, amended, or affected in any way by this amendment and remain in full force and effect. For that reason, these subsections are not set forth here in full.)

A. Adoption: The Plumbing code approved by the County of St. Louis on July 14, 2010 as Ordinance #24441 (Exhibit B) and will become effective on November 1, 2010, is hereby adopted as the plumbing code of the City of Normandy as if set forth here in full.

Section Three.

Subsection A of Section 500.050 of Article II of Chapter 500 of Title V of the Normandy, Missouri City Code is hereby amended by repealing in full said Subsection A and in lieu thereof, enacting a new Subsection A to read as follows:

CHAPTER 500

BUILDING AND CONSTRUCTION REGULATIONS

SECTION 500.080 MECHANICAL CODE

(NOTE: Subsections B & C are not altered, amended, or affected in any way by this amendment and remain in full force and effect. For that reason, these subsections are not set forth here in full.)

B. Adoption: The Mechanical code approved by the County of St. Louis on July 14, 2010 as Ordinance #24438 (Exhibit C) and will become effective on November 1, 2010, is hereby adopted as the mechanical code of the City of Normandy as if set forth here in full.

The Chapter, Article, Division and/or Section assignments designated in this Ordinance may be revised and altered in the process of recodifying or servicing the City's Code of Ordinances upon supplementation of such code if; in the discretion of the editor, an alternative designation would be more reasonable. In adjusting such designations the editor may also change other designations and numerical assignment of code sections to accommodate such changes.

Section Four.

This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
