**AN ORDINANCE AMENDING SECTION 600.070 OF
THE NORMANDY, MISSOURI, CITY CODE RELATING
TO TYPES OF ESTABLISHMENTS ELIGIBLE FOR
LIQUOR LICENSE.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
NORMANDY, MISSOURI, AS FOLLOWS:**

Section One.

Subsection A. of Section 600.070 of Chapter 600 of Title VI of the Code of Ordinances of the City of Normandy, Missouri, is hereby repealed and a new Subsection A. of Section 600.070 is hereby enacted in lieu thereof to read as follows:

TITLE VI BUSINESS AND OCCUPATION

CHAPTER 600 ALCOHOLIC BEVERAGES

**SEC. 600.070 TYPES OF ESTABLISHMENTS ELIGIBLE
FOR LIQUOR LICENSE**

- A. *Package Liquor Licenses.* Only one license shall be issued, within the City, for the sale of intoxicating liquor in the original package, not to be consumed upon the premises where sold. Such license shall only be issued to a person engaged in, and to be used in connection with, the operation of one (1) or more of the following businesses: a drug store, a cigar and tobacco store, a grocery store, a general merchandise store, a confectionery or delicatessen store, having and keeping in his/her store a stock of goods having a value according to invoices of at least one thousand dollars (\$1,000.00), exclusive of fixtures and intoxicating liquors. Under such license, no intoxicating liquor shall be consumed on the premises where sold nor shall any original package be opened on the premises of the vendor except as otherwise provided in this Chapter or law. Under such license, with the exception of wine and beer, no intoxicating liquor shall be sold in units of one half of one (1/2) pint in volume or less.

Persons having or obtaining a license for the sale of alcoholic beverages by the drink, as set forth in Section 600.020(5)

above, shall, subject to the requirements for application, approval and payment as set out elsewhere in this Chapter, also be eligible to obtain a license for the sale of alcoholic beverages in the original package not for resale and not for consumption on the premises where sold, as set forth in Section 600.020 (1) and (2) above, for use at the licensed premises, all other provisions of this Section to the contrary notwithstanding.

[The balance of Section 600.070 remains unchanged]

Section Two.

It is hereby declared to be the intention of the City Council that each and every part, section and subsection of this Ordinance shall be separate and severable from each and every other part, section and subsection hereof and that the City Council intends to adopt each said part, section and subsection separately and independently of any other part, section and subsection. In the event that any part of this Ordinance shall be determined to be or to have been unlawful or unconstitutional, the remaining parts, sections and subsections shall be and remain in full force and effect.

Section Three.

The Chapter, Article, Division and/or Section assignments designated in this Ordinance may be revised and altered in the process of recodifying or servicing the City's Code of Ordinances upon supplementation of such code if, in the discretion of the editor, an alternative designation would be more reasonable. In adjusting such designations the editor may also change other designations and numerical assignment of code sections to accommodate such changes.

Section Four.

This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
