PERSONAL CONDUCT IN CITY PARKS

NO PERSON IN A CITY PARK SHALL:

- 1. Have exclusive use of the park without first obtaining a permit from City Hall.
- Have in his possession any alcoholic beverages in excess of five percent by weight or volume. Picnickers may use beer or wine with their picnic lunches, as long as they conduct themselves in an orderly manner. ALL ALCOHOLIC BEVERAGES, INCLUDING BEER AND WINE, ARE PROHIBITED FROM ALL ATHLETIC FIELDS AND BENCHES. THIS INCLUDES ALL PLAYERS, COACHES, AND SPECTATORS. {Ord: 240 320 1}
- 3. Enter a park under or be under the influence of intoxicating liquor. {Ord: 240.320.2}
- 4. Have in his possession, or set off or otherwise cause to explode or discharge or burn, any type of fireworks or other explosives or inflammable materials or discharge them or throw them into any such area from any land or highway thereto. {Ord: 240 320.3}
- 5. Permit any dog under his control or care to enter or remain in a park, unless it is led by a leash of suitable length not more than six feet in length; and the owner or attendant shall be responsible for any damage caused, in any event, by such dog, even if on a leash. {Ord: 240.320.4}
- 6. Play or bet at or against any game conducted in the park; maintain or exhibit any gambling table or other games prohibited by any ordinance of the City of Normandy. { Ord: 240 320 5 }
- 7. Use any system for amplifying sounds, the total output of which amplifiers, including the sum of the wattage output of each channel, exceeds twenty-five watts. {Ord: 240.180}
- 8. Sleep or protractedly lounge on the seats, benches or other areas, or engage in loud, disorderly conduct or behavior tending to a breach of the public peace. {Ord: 240 320.6}
- 9 Remain, stay or loiter in any park between dusk to dawn of the following day. { Ord: 240.320.7 }
- 10. Leave any garbage, trash, cans, bottles, papers or other refuse, in any area other than in the receptacles provided therefore. {Ord: 240 210}
- 11. Drive any vehicle on any area except the paved park roads or parking areas. {Ord: 240.160}
- Light or maintain any fire in a park, unless such fire is maintained in a receptacle provided for such purpose. {
 Ord: 240.290 }
- 13. The following fees are hereby established for the reservation and use of pavilion facilities in Hoelzel Park; the sum of thirty dollars (\$30.00) for Pavillion #1; twenty-five dollars (\$25.00) for Pavillion #2 shall be paid by any resident of the City of Normandy who wishes to reserve the use of pavilion facilities, and the sum of sixty dollars (\$60.00) shall be paid by any person who is not a resident of the City of Normandy who wishes to reserve such facilities. Baseball fields are not included in pavilion rental.

- 14. The following fees are hereby established for the reservation and use of baseball field # 2 in Hoelzel Park; the sum of ten dollars (\$10.00) shall be paid by any resident of the City of Normandy who wishes to reserve the use of baseball field # 2 per 3-hour rental, and the sum of twenty dollars (\$20.00) shall be paid by any person who is not a resident of the City of Normandy who wishes to reserve the use of baseball field # 2 per 3-hour rental. Field # 2 is the smaller all dirt ball diamond. The larger field with grass infield is not a rental field.
